

## Information for Candidates – 27 September August 2019

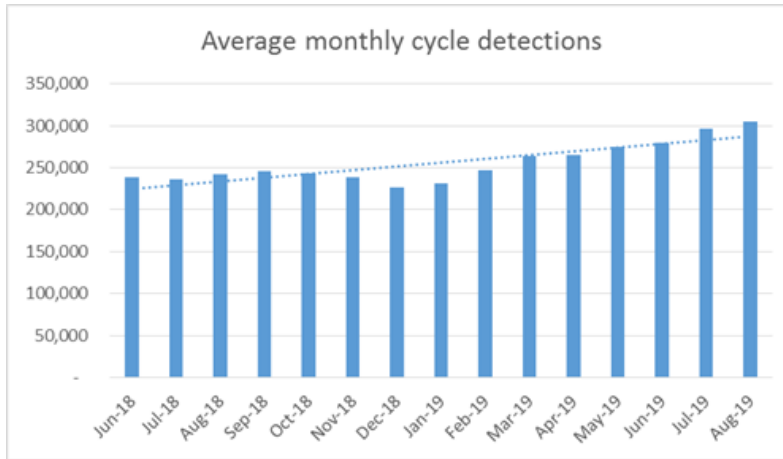
The following information was provided to candidates or affiliated parties by the Christchurch City Council. In fairness to all candidates this has been published online:

- 1. The following information was provided to a Candidate regarding cycle numbers in Christchurch (Papanui Parallel, Papanui Road, Antigua Street Bridge, Worcester Street, St Asaph Street and Hagley Park Unicycle)**

With regards to the information requested, we collect live data at 26 locations on 7 Major Cycle Routes across the network.

Overall, for the combined dataset we have recorded the following monthly detections since June 2018. Please note that the data are related to the same number of sites during the entire period. The reported cycleways are Heathcote Expressway, Little River Link, Northern Link, Papanui Parallel, Quarrymans Trail, Rapanui-Shag Rock and Uni-Cycle.

The observed annual growth is currently more than 20% per annum and increasing.
