



I am pleased to see the majority of trees are being kept and the feel of the main reserve is being kept to woodland with additions fitting in with this. I would like any additions to the area to be in majority natural materials and the compliment the area we live in. I feel that I was not specific in my last submission and so I have given a lot more detail in this one. As well as running the local preschool playgroup I am a specialist Neurodevelopmental Occupational Therapist. I am not only making this submission for myself but for the needs of group of our community whos needs have been widely overlooked in this proposal. I have not been running the group for the fun of it but more because I feel this group of people need an opportunity to meet, make friends, talk, socialise and support each other through a very challenging time of their lives. Adjustment to being at home with a baby or young child alongside social isolation can have very negative effects on peoples mental health and the ability they have to provide a safe and nurturing environment for their babies and young children. There is no public transport in the bay and many people find the volunteer service too restrictive and stressful to manage due to its pre book system.

I have in the past seen a number of children regularly using the area for BMX biking, this has tailed off more recently, I would like to see them use this area more and I would agree a more substantial area with higher challenge and skill level would hopefully be very attractive. I am however very surprised to see a half pipe in the plan. I have on rare occasions seen a skateboard being used in the bay. I live by the school which is the only tarmac area which I would say suitable for skateboards and I just don't see them about, they are not brought to the school of wheels day and I just don't see them being used. If there is a high need for a skate area please make it more usable for a broader range of children and ages for use with boards, bikes and scooters or make an area off the pump track for more skill work on bikes and scooters which are used a lot more here.

The older children certainly seem to have a large majority of the new facilities which is great for them however I am very disappointed to see that the younger children have been very poorly represented. The old preschool play area was removed and it feels unfair that very little is being given in its place. I understand and agree that swings would be valuable in the bay however I feel very strongly that they should not take over the safe area which has previously been given for younger children. Older children have the school play area across the road and can use this in school and out of school hours. The preschool group is run in the community centre at the heart of the village and this area would be so well used during this group and out of the groups' hours.

The time a pre-schooler and their main carer spend locally in the first 5 years of life is well worth investing in. The pre-schoolers themselves are unable to make a submission as they cannot write or manage a computer, many of the parents didn't manage to get submissions in due to managing life and sleepless nights! And many of us just assumed that you would replace the previous play area with something worth playing on.

Ideas which I feel strongly about are

- Increase the area of the current play area north east of the community centre to accommodate more play opportunities.
- The child swings should be relocated within the main body of the development as you have provided a lot for this age group already.

The play area would be really beneficial to babies and younger children if it included

- Slide
- Seating to meet needs of feeding parents, children and adults to meet socially for food and games.
- Tunnel to give feelings of squash and squeeze and peek-a-boo. This could be concrete or plastic or even a willow planted tunnel.
- Climbing logs/ stumps/ boulders on several different levels and ramps/ ladders to encourage climbing, jumping, balance and agility and risk taking.
- Planters or area left to allow planting of herbs and edible plants and grasses to give both a barrier and kids love to brush through them, fall on them and slide off them.
- An element of swinging for vestibular development.

The ideas that take some attention and care such as the planter boxes and the willow tunnel etc I am happy to coordinate. Reusing the logs from the trees cut from the reserve area would be great recycling and give fantastic climbing opportunities and even some exciting seating.

I feel more seating/ picnic areas would be beneficial, there were more before the centre was rebuilt and with all these new and exciting additions there will be more people using the area.

I would so love to see the little people of Governors Bay have some where to play as they have a lot of skills to develop in the first few years of life and we should be providing fun places for them to learn, have fun and be active health kids.

SUBMISSION ON GOVERNORS BAY COMMUNITY CENTRE AND POOL RESERVE LANDSCAPE PLAN

Details of submitter

- 1. Canterbury District Health Board (CDHB).
- 2. The submitter is responsible for promoting the reduction of adverse environmental effects on the health of people and communities and to improve, promote and protect their health pursuant to the New Zealand Public Health and Disability Act 2000 and the Health Act 1956. These statutory obligations are the responsibility of the Ministry of Health and, in the Canterbury District, are carried out under contract by Community and Public Health under Crown funding agreements on behalf of the Canterbury District Health Board.
- 3. The Ministry of Health requires the submitter to reduce potential health risks by such means as submissions to ensure the public health significance of potential adverse effects are adequately considered during policy development.


Details of submission

- 4. We welcome the opportunity to comment on the Governors Bay Community Centre and Pool Reserve proposed landscape plan. The future health of our populations is not just reliant on hospitals, but on a responsive environment where all sectors work collaboratively.
- 5. While health care services are an important determinant of health, health is also influenced by a wide range of factors beyond the health sector. Health care services manage disease and trauma and are an important determinant of health outcomes. However health creation and wellbeing (overall quality of life) is influenced by a wide range of factors beyond the health sector.
- 6. These influences can be described as the conditions in which people are born, grow, live, work and age, and are impacted by environmental, social and behavioural factors. They are often referred to as the 'social determinants of health¹.

The diagram² below shows how the various influences on health are complex and interlinked.

7. The most effective way to maximise people's wellbeing is to take these factors into account as early as possible during decision making and strategy development. Initiatives to improve health outcomes and overall quality of life must involve organisations and groups beyond the health sector, such as local government if they are to have a reasonable impact³.

General Comments

- 8. The CDHB supports the overall intent of the proposed landscape plan for the Governors Bay Community Centre and Pool Reserve. These improved local amenities, including the introduction of play equipment and a pump track, will contribute to the health of the population through providing increased opportunities for physical activity and community connection.
- 9. The CDHB has a number of recommendations for consideration which would further improve the accessibility of the reserve to ensure that all people have the opportunity to enjoy the amenities provided and to increase the potential utility of the improvements.

Specific comments

- 10. The CDHB highlights the importance of full accessibility of the new pathway connecting the community centre and the pool, to allow wheelchair users or those with impairments to access this link. Considerations include pathway width, surface material, evenness, firmness and gradient and ensuring there is an accessible route that does not include steps.
- 11. The CDHB recommends that the softfall under the new swings and boat be of a material that ensures accessibility to those in wheelchairs. This is of particular importance as this is the part of the reserve that is most accessible to those with limited mobility, due to the proximity of this area to the Mobility carpark.
- 12. The introduction of seating, perhaps more of the same standard accessible design as shown in the proposed picnic table near the half pipe, is also recommended in the area beside the swings, as this encourages social interaction between community members. This area would also benefit from shading from the sun and a drinking water fountain.
- 13. While the CDHB acknowledges that all the proposed play equipment may not be suitable for those with disabilities, it is recommended that consideration be given to designing it to be as accessible as possible. For example, the tree house could be designed in such a way that those in wheelchairs can access a lower part of the treehouse via a ramp leading to an area of interest. Also, the rowing boat by the swings could be designed to ensure that wheelchair users can access the

equipment by, for example, removing the back of the boat and replacing it with ramp access.

- 14. The CDHB recommends that consideration be given to the new garden beds between the pool and the community centre being designed and maintained as a community garden project, incorporating edible plants. These types of projects benefit individuals by giving people access to fresh, organic produce, by promoting physical activity, and by stimulating learning and adding to a person's knowledge and expertise. Community gardens also have social benefits through promoting community interaction, providing a venue to meet new people and building a sense of community.
- 15. The CDHB recommends that a CPTED audit is completed to ensure adequate lighting and other measures are in place to ensure the safety of those using the area.

Conclusion

- 16. The CDHB does not wish to be heard in support of this submission.
- 17. If others make a similar submission, the submitter will not consider presenting a joint case with them at the hearing.
- 18. Thank you for the opportunity to submit on the Governors Bay Community Centre and Pool Reserve Draft Landscape Plan.




