Decreasing the speed limit would: 1) increase the safety for all vehicles travelling along all of these roads; 2) provides safety for the families who live in the residential 50km/h zone west of Crofton Road; and 3) reduce personal trauma to my family caused by constant shaking and jolting of our house.  1. Travelling at 60km rather than 70km would reduce casualties in an accident. Research conclusively demonstrates the relative risk of a car becoming involved in a casualty crash (a car crash in which people are killed or hospitalised) for cars travelling at or above 60 km/h doubled for every 5 km/h above 60 km/h. The likelihood of accidents is also increased: a car travelling at 65 km/h is twice as likely to be involved in a crash as a car travelling at 60 km/h (source: NZ Police).  2. The severity of injuries resulting from a crash is directly related to how fast vehicles were travelling before the crash. In the area west of Crofton Road, traffic rarely obeys the 50km speed limit. Traffic going west is speeding up to 70km prior to the 70km zone. Traffic going east is only starting to slow down at Crofton Road. Families live here with children and pets. The probability a pedestrian will die increases rapidly with relatively small increases in speed. For example, a pedestrian struck by a vehicle at 40km/h has a 70% chance of survival; 95% of pedestrians die when struck at 70km/h (source NZTA). There are no speed control measures on Sawyers Arms Road east of Crofton Road meaning drivers are not conscious of the 50km/h residential zone.
