This simply means beach goers have to walk down to the beach.</p> <p>Another suggestion is for a sign saying Residents Parking Only past this point at the top of both entries into Rapaki, Whanau will park at their relatives or on the reserves.</p>	After considering the feedback of the one way system, staff are not recommending this option. Council staff are considering parking information signage, which may assist when the lower parking area is running to capacity. 19631	yes	no	<p>After considerable discussion at runanga meetings and around the community the following submissions have been agreed upon.</p> <p>Submission 1) In favour of no stopping lines in all of Rāpaki Drive, Kina Road, Korora Tahī Rd and Omaru Road.</p> <p>Submission 2) Against any one way system. Too many downsides were identified with either a one way down Rapaki Drive or down Kororatahi Road. Most of the traffic problems are in the busy summer period and can be largely addressed through the measures outlined in submissions 1 and 3.</p> <p>Submission 3) In favour of give way signs on Kina Road on the east and west side of Rāpaki Drive. These give way signs in conjunction with the trialing of a new entrance to the Jetty carpark (as per the sketch attached with red lines indicating entry points and yellow lines the exit point) could eliminate the traffic jams that happen at this intersection. Signage will encourage traffic to enter the carpark from that entry point and exit from the jetty end. Because the new entrance way would be on private land (as the whole eastern end of the Jetty carpark is) we have commenced consultation with the landowners concerned and those spoken to so far are supportive. Assuming CCC approve what is being proposed this could be trialed over the summer to see how it works. Given this won't be decided upon until you meet December 17th it is hoped the no stopping lines and give way signs can be installed as soon as possible after the meeting to help us deal with the summer traffic.</p>	<p>After considering the feedback of the one way system, staff are not recommending this option. 19464	no	no	<p>1 - there are only 13 properties that are directly affected on a daily basis by this proposal and no consultation has been carried out with these affected parties. I note that the committee has only one affected party as a member.</p> <p>2 - the issue in Rapaki is associated with parking and not the access roads, there is no public parking in Rapaki there is only allowed parking by the wharf and yellow lines around the access roads would help the locals when entering or leaving Rapaki.</p> <p>3 - the parking issue in Rapaki is directly related to the Xmas holidays and therefore only small part of the year but these proposals would have a permanent effect on those directly affected parties.</p> <p>4 - the access roads are narrow but in the 22 years I have lived here there have been no issues with passing vehicles, there is an issue with the trees encroaching the road along part of Korora Tahi Rd.</p> <p>5 - creating this one way system means that there is on options available to residents if the road is blocked, presently vehicles just turn around and go the other way.</p> <p>6 - emergency vehicles would be limited to using the one way system, some of the bends are tight, sharp 90deg, and these large vehicles would be slowed down in an emergency</p> <p>7 - in the event of roadworks or any other works, a council road closure order would be needed, a council approved traffic management plan would need to be prepared and multiple traffic lights required, currently residents just turn around.</p> <p>8 - access from the marae to the ura pa, will require vehicles to exit Rapaki, turn around in the bus bay and re-enter Rapaki</p> <p>9 - there is a 20kmh speed limiting in Rapaki and in generally people drive responsibly, implementing this one way system would encourage people to drive faster especially at the corners as there is no possibility of meeting another vehicle</p> <p>10 - in the event of an emergency the affected residents would have only one possible legal exit route, currently we have two</p> <p>11 - the junction at the top of the playground is too tight for most vehicles to change direction and therefore vehicles will need to exit Rapaki cross the main road and turn around before coming back down the road in the desired direction.</p> <p>In summary we object to this proposal.</p>	<p>After considering the feedback of the one way system, staff are not recommending this option.</p> <p>'The trees encroaching the road along part of Korora Tahi Rd'.
