21906	<p>As a local tour operator in the Canterbury region, I have seldom included the Summit Road in our city sights tours, post earthquake, due to not being able to do the complete circuit past Mount Cavendish.</p> <p>Similarly, I look forward to the Evans Pass "" Lyttelton road being re-opened at the end of the month so we can include Sumner without back-tracking.</p> <p>However, I have occasionally used the Gebbie's Pass "" Sign of the Kiwi section and guests on board have been aghast at the skid marks on sections of that road. I don't think that lowering the speed limit will actually stop the 'boy racers' congregating there, obviously in the middle of the night when they don't affect me but must annoy the few local residents in that area.</p> <p>Maybe the 'no stopping after hours' bylaws similar to Harper Ave would help give Police the 'teeth' in these areas. Then, with the limited access to that area it should be reasonably easy for the Police to block that access to bring about prosecutions. 21930	<p>I strongly support a lower speed limit along Summit Road. In terms of driver/car safety, the road is narrow, has multiple unposted sharp bends, blind corners and no shoulder space to avoid oncoming traffic or cyclists. High speed limits encourage people to cut corners and often lead to drivers losing control - this is illustrated by the high number of cars that drive off the bank along this road.</p> <p>Recreational users are also important to consider. The Summit Road area is the city's most popular for walking, road biking and mountain biking. These users are incredibly vulnerable to poor decision-making and antisocial behavior by drivers. Even at 60km/hr, a pedestrian or cyclist is likely to be critically injured or killed in a collision with a car, so I consider the proposed reduction to be the bare minimum to maintain a safe and enjoyable recreational area. I would prefer that the section between Godley Head and Marley's Hill is lowered to 50 km/hr as this section is the most heavily used by walkers/cyclists and the multiple tight, blind corners and narrow width of the road don't allow for vehicles to safely exceed this speed regardless.</p> <p>A final point to consider is the enforcement of posted speed limits on Summit Road. Most of Christchurch is aware that 'boy racers' see this road as a race track and target it during both the day and night as they know there are no speed cameras or traffic police. The fact that many accidents in NZ happen at speeds in line with the posted speed limit are an indication that legal speed limits are too high, not that speed is not a factor in the accident. A decrease in speed makes driving safer for no other reason that it permits drivers a longer reaction time. The Summit Road passes through Mt Vernon Park (the park is partly above and mostly below the Summit Road. The Road was formed primarily for transport purposes although it is used by some recreational users of the park, for example rock climbers and disabled persons accessing the Lamar Track on Mt Vernon Park. It is also important for access for emergency services.</p> <p>In the last few years we have observed a rapid increase in recreational use of Mt Vernon Park by walkers, runners and especially by mountain bikers. These recreational users also freely use and cross Summit Road and do not mix safely with motor vehicles travelling at a greater speed than 50km/h.</p> <p>We regularly (perhaps averaging twice a year) suffer damage to livestock fences along the Summit Road boundary through vehicles going off the formed road at speed and through our fences. The Society's mission statement is "Working to enhance, preserve and protect the natural environment, beauty and open character of the Port Hills of Banks Peninsula for people to enjoy".</p> <p>The Society's goals are:</p> <ul style="list-style-type: none"> To help preserve and enhance the native forest, shrublands and tussock grasslands and associate fauna To develop and maintain tracks and other amenities To seek to minimise residential encroachment and the erection of intruding structures To encourage protection by purchase or other means to develop parks and reserves for public benefit To promote pride in the Port Hills and Summit Road and provide informational services and educational activities To promote integrated management and inter-agency collaboration for the Port Hills and Banks Peninsula <p>The Society has a strong interest in the Summit Road. A legacy of Harry Ell, the Summit Road is an important thoroughfare for those living and visiting the Port Hills and the only road in New Zealand protected by statute.</p> <p>It is regularly used by our work party members as well as locals and visitors wanting to enjoy the Port Hills.</p> <p>The safety of all road users, both motorists and cyclists, is a priority. We must find a path forward that recognises that a mixture of people use Summit Road, from locals who are very familiar with the road to recreational cyclists to visitors to the city.</p> <p>The road itself is challenging. It is narrow and windy and cut into hillside. Our members and work parties have observed a range of dangerous driving behaviour up on the hills, including driving too fast for the road and conditions, taking corners too fast and crossing the centre line.</p> <p>We support the change to 60km per hour on the Summit Road and the adjoining side roads, Broadleaf Lane, Worsleys Road, Mount Pleasant Road, Evans Pass Road and Sumner Road. We know reducing speed helps reduce accidents and helps reduce the likelihood that accidents will result in death or serious injury. We believe that the 60km per hour speed limit would send a clear message that drivers need to slow down on these narrow windy roads.</p> <p>We would take this opportunity to promote the Society's aspiration for the Summit Road to become a heritage park way. Heritage park ways are essentially scenic drives that commemorate historic routes. The road and signage are designed to maximise the view and discourage high speeds. The Society has also long supported the concept of the Summit Road as a heritage road. In 2009, the Summit Road Protection Authority sent a document to the Council outlining their proposal for a "Heritage Road through a Park". This document outlined the changes in how the road is used since its original creation and a new vision for the future. Recommendations focused on enhancing the Road's status, protecting its heritage, promoting its values and streamlining and improving its management.
