23510	<p>To whom it may concern,</p> <p>I am the President of OBC and to say we need these urgent upgrades in an understatement.</p> <p>We are the quiet achievers of the local area for what we provide for cricket in the local area. We are the largest club in the south island and the third biggest in NZ. Simply the volume of members and their demands doesn't fit the current facilities. For summer we use the park 6 days a week for 6 months of the year. We have 50 junior teams of both male and female that we have to fit into our tired and unfit nets to provide coaching and development. We try to be inclusive and encourage members to use the nets anytime, but its simply dangerous with the current layout. If a game is on the number 1 block, users of the nets are interfering with the game. So this is why we are endeavoring to move them to the other side of the park and we have looked to enclose the nets to protect all users of the park, and also that the nets can be used anytime of day for all of our members. To undertake this project is not cheap, we have been very diligent with our fundraising to make sure this project gets completed.</p> <p>My greatest fear is that other park users that walk/run/take their dog out, are going to get hit as the nets are simply dangerous. So this is why we have enclosed them, the ball 'should not' escape and everyone should be able to use the park safely.</p> <p>Pavilion - It simply a need. We have no base, for the club which we need to address. We need to have a home and something that all club members can come back to each weekend. We are trying to be inclusive with winter sports, any local schools that need to use it during the day for sports events/carnivals. This is an asset for the local area, that will complement The Elmwood club. If and/or when that gets going, there is nothing on the park side in the way of facilities. Having played at High School Old Boys CC since 1999 and then been at the club through the merger to Old Boys Collegians I have seen what it is like to have good facilities, and conversely not so good.</p> <p>H SOB were situated on Hagley Park and generously sold off their former clubhouse to accommodate the fantastic new Hagley Oval Pavilion. Due to this, Old Boys Collegians' home ground is now Elmwood Park. And whilst the grounds are picturesque the facilities are now outdated and dangerous.</p> <p>The biggest loss for me has been the lack of an identity. We have had nowhere to display our honours boards - which incidentally are numerous - many first class players, and according to one of our senior members the most NZ representatives out of any club in the country, including names like Sir Richard Hadlee, Brendon McCullum, Shane Bond, Corey Anderson, Todd Astle, Katey Martin and Erin Birmingham. We've also been home to overseas international players like Graeme Swann of England, Logan van Beek of the Netherlands and Craig Wallace of Scotland. We also count shot put legend Tom Walsh as one of our own.</p> <p>Cricketers are statistics-mad people and we've had nowhere to display individual honours. There is also nowhere for past players to come along and mingle, they are an important part of our history and are currently somewhat neglected.</p> <p>We have the second most amount of junior teams for any cricket club in NZ. Yet, our net facilities overlap the main outfield, so juniors are hesitant to use the nets on a Saturday and so don't mingle with the senior side of the club. And if they do they are limited to basic games within the net. 23536	<p>I am opposed to siting the practice nets in the new location for the following reasons:</p> <p>Noise - the new nets will be directly in front of peoples' homes, including my own, with no sound barrier. Homeowners will have to endure the noise of balls being hit and people shouting at all times of the day. The current nets are opposite the tennis courts and homeowners in the NE corner of St Andrews Sq are sheltered from the noise by the pavilion.</p> <p>Safety - The Council's background notes state that the current location of the nets presents pedestrian safety issues. The proposed site is opposite the Elmwood Croquet Club, many of whose members are seniors and have mobility issues. The coaches provided by OBCC Club provide a nurturing environment for my girls to learn new skills, improve their fitness, enhance their wellbeing and mix with players of all ages from throughout the Christchurch region. A venue they can feel comfortable using and encouraged to socialise in during and after games will certainly go a long way to help.</p> <p>Elmwood Park is a sea of kids, both boys and girls, on most summer weeknights as the club provides coaching for players from age 5 through to 18. In the weekend it plays host to games involving young kids playing their first season of cricket, right through to Premier Mens and Womens Teams involving many Canterbury Representative players. These players need the facilities the club is proposing be built at Elmwood Park.</p> <p>The OBCC Club is also the home club to the majority of the Heaton Girls Cricket team - National Primary School Champions for 5 of the past 6 years, and provides facilities for these girls to train and play practice matches against local schools.</p> <p>To keep improving the skills of these players they need adequate facilities to train.</p> <p>Where the nets are currently located is dangerous for players and for the public with a walkway running directly behind the nets. The run up areas are constantly causing injuries as the grass is unable to grow quickly enough and ruts develop for the heavy use they are subjected to for 6 solid months of the year. It would seem that a lot of planning has been undertaken already without appropriate input from the surrounding community and other key users of Elmwood Park. 2. I am concerned that many frequent users of the park will still not be aware of the proposals due to the limited signage that has been erected to notify people of these significant planned changes. For example, a lot of people enter and exit the park regularly via the alleyway nearest to the croquet club for a range of reasons (e.g. to use the playground, to exercise, to exercise pets, en route to public transport on Heaton Street, etc) and there has been nothing at this busy entrance/exit that alerts these people to this proposal. The proposed relocation of the cricket nets, in particular, would be potentially of interest and perhaps concern to many of these park users. 3. I do not support the club rooms being rebuilt in a position that encroaches on the area within Elmwood Park which is currently grassed. However, I am not opposed to the club rooms being rebuilt on their current footprint. 4. I do not support the cricket nets being rebuilt in the proposed position.
