I think it is only fair to point out that both Old Collegians' and Old Boys Cricket Clubs (OBCCC's parent clubs) have a history of cricket being played at this park since the 1920's - nearly 100 years of near continuous cricketing history. When I joined Old Collegians in 1986 the ground had 4 senior wickets where now there are only three. During the 1990s when Junior cricket numbers at Old Collegians peaked - on Saturday mornings up to 10 or 12 junior games (nearly 200 junior players plus supporters) plus the cricket nursery with more than 100 children and parents supporting them would attend the park each morning, to be followed by 4 senior games (88 players) all afternoon. During the week junior crickets trained all over Elmwood park on as many as 4 days a week after school followed by senior cricketers in the evening 2 days per week. By comparison current levels of cricket activity are significantly lower. In addition the proposed net facility will actually localize the impact of junior cricket training to a much smaller footprint on the park and be much safer. For senior players the current net run ups are on to the main field and are dry and bumpy, the risk to a fielder on the boundary trying to stop the ball in this region of the field is high and I have witnessed many close calls. Because the run ups for the nets are on to the main senior field, children either don't use the nets during Saturdays out of fear of getting hit by balls from the main field. Those that do are often getting told off for hitting balls out on to the main field, delaying the game on the main field. Simply, the current nets are too dangerous. I am a registered physiotherapist in New Zealand and see a range of different people in our clinic with a wide ranging degree of issues they seek help for. One ACC contract I work on is the NZ concussion contract. I see people that have had what is classed as mild to moderate 'concussion' injuries who in some cases have had ongoing symptoms for 1 year or more. The effect on these peoples lives, their families lives, their work and social lives is significant. To say that a concussion based injury, other bodily injury or a severe head injury is possible from the design of these nets is an understatement. The main safety issue I see with the current nets are; - The open nature of the bowling lanes means batsman are hitting back toward other people, often across to other lanes endangering those training in other net lanes. Moreover, the direction the nets are facing means batsman are hitting out toward the middle of the park. Many members of the public and community often walk or exercise in this area and are certainly endangered. I would hate to see anyone hit by a cricket ball and suffer a life changing injury. - Adds to traffic problems.
- Is being operated illegally with the Councils knowledge

OBJECT TO THE MESS THAT THE CRICKET CLUB LEAVES THE PARK AND THEIR USERS

- beer bottle lids thrown around park after matches
- bottles & litter dropped around the park, over flowing bins and litter around surrounding houses left for neighbours to clean
- apparatus and equipment dumped behind buildings, area that is part of the green-space and raises concern that this area will only be much larger if pavilion is enlarged and pushed out into the green-space

OBJECT TO THE NOISE POLLUTION

- The additional facilities add to the larger numbers of cricket users and the after game celebrations and drinking in this public open park. This evidence has been shown in photos showing the numerous crates of beer bottles behind the temporary cricket buildings.

GROWTH IN LOCAL COMMUNITY

There is continued growth in the local community with infill housing. For well being and mental health, green-space is of absolute importance to this growing community and Elmwood Park plays a very important role, especially for the local community that are in walking/running distance from the park.

The park has been shared by other sports for local community clubs for many years with good balance. Although the local community is growing with infill housing, Elmwood park can not. Amalgamation of clubs on top of the growing infill housing is creating undue pressure on the nature of this precious green-space.

The amalgamation of Old Collegians and High School Old Boys in 2004 has more than doubled the number of people and made the club more of a regional club, rather than a local club. This has added to the growing park user numbers that continue to climb due to infill housing.

This is even more troublesome with the so-called sub-tenants of the Elmwood Bowling Club that entered the area post earthquake. The Elmwood Club moved into the Earthquake ravaged Elmwood Bowling Club building. They even come from out of Christchurch district with associated clubs from Selwyn district such as Lincoln and I believe Prebbleton as well as all over Christchurch.

Elmwood Park can only grow if the council acquires further property. Taking away the green-space from the community to add more buildings and structures only provides for even more overcrowding of this already overcrowded park.

Elmwood Park Submission – Bob Pringle

We have lived in for 23 years. Our property boundaries the Elmwood Park north boundary fence and is directly in line with the main oval wickets.

We did not object to the OBCCC new pavilion proposal nor do we object to Elmwood Park being the home ground and base for a successful and competitive cricket club. Having lived in close proximity to the main wicket and the existing practice nets/clubrooms for 23 years we are very familiar with noise issues associated with cricket irrespective of whether that noise is generated during senior weekend or week night competition, twilight club practice sessions or junior cricket coaching sessions, all of which are literally over our back fence. The level of noise generated to date from playing or practicing cricket in the park is no more and no less than any reasonable person would expect and we do not find it objectionable. Likewise we have never complained about the peppering our back yard has received from sixes hit from the main pitch over the last 23 years nor have we begrudged helping players find/retrieve balls. In summary we have to date had no axe to grind with OBCCC. More particularly the club has had no axe to grind with us.

I however, along with my extended family (and hundreds of other members of the public) are regular users of this beautiful and unique park. I am totally opposed to the OBCCC proposal to construct a 37m x 14m (518m²) four lane practice net configuration adjacent to the parks Eastern pathway.

According to data supplied by Council, the new pavilion, in conjunction with the proposed net configuration will impact 93 metres of the East boundary, compared with the current clubrooms/nets configuration, which impacts only 45 metres of the East boundary.

Additionally, the proposed nets being four lanes wide, will require 5 x 37m lengths of 'view obliterating' rows of netting and is untenable given the unique heritage status of Elmwood Park and is an insult to the hundreds of citizens who use the park.

Background:

OBCCC initially proposed siting fully enclosed nets on the western side of the park, near the Croquet Club. Neighbours, along with the Croquet Club, objected to this proposal. In response to these objections OBCCC, presumably in conjunction with Council staff, proposed moving the 518m2 net configuration to the East path boundary.

The club's proposal was then returned to the Community Board meeting on 9 September 2019. The lease was not granted at that time, with Council staff requested to further consult with the Club and the community.

This decision by the Community Board was carried by a vote of 5-3 and the board members who voted in favour of this motion are to be congratulated for their foresight in recognising that simply approving moving the 518m2 net configuration from one side of the park to another, without further consultation, would not be in the best interests of the park or the large numbers of the public, other than cricketers, who use the park. Particularly when many of the objections raised to

this initial proposal, other than those based on NIMBY reasons, equally applied to the same nets configuration being constructed on the other side of the park i.e. adjacent to the Eastern pathway.

Further Consultation:

At a meeting attended by OBCCC representatives, Council staff and members of the public held at Elmwood Park on 8 January, Steve Wakefield, on behalf of the OBCCC, gave a presentation on other options for nets considered by the club.

Option 6: The club concluded for various reasons, not all convincing, that the position of the new nets needed to remain 'as proposed' adjacent to the Eastern pathway i.e. $4 \times 37m \times 3.5m$ netted lanes on Astroturf covering an area of $518m^2$ except that 18m of the 37m length would be permanent with the remaining 19m retractable i.e. removed during the off season (stated as 1 April-31 August).

I disagree with this proposal for the following reasons:

- a) I doubt the nets will be reduced in size from 1 April. This is based on the fact that the existing nets continue to be used throughout April.
- b) The impact of the 37m long 518m configuration for 8 months of the year is untenable.
- c) One assumes, given the Astroturf, that the reduced nets will remain available for use during the winter. Their North-South orientation i.e. running parallel to the Eastern pathway and open ended, will be a greater safety risk than the East-West orientation of the existing nets.
- d) There are alternative options to the OBCCC Option 6 proposal (refer Alternative Proposal below).

Cricket Club Associated Submissions – Other Christchurch Cricket Clubs

While a number of submissions in support of the initial proposal (Pavilion, net area configuration etc.) are valid, I am somewhat appalled that the cricket clubs proposals give little consideration to aesthetics or the historical, social, cultural and architectural significance of the park.

My summary of the situation is that the club view Elmwood Park being there primarily to provide for their needs, with little consideration given to the views of the wider community.

I would also make the point that the 'Have Your Say' document put out by Council failed to show what actual impact the new pavilion and nets proposal would have on the parks Eastern boundary. Of the people I discussed the proposal with, none were aware of the total impact the nets configuration would have. Consequently there a many people who rely on the Community Boards integrity to look after the park.

In order to understand what is necessary, fair and/or reasonable I have had to carry out significant research. This includes gathering information from Council as well as travelling to numerous other cricket clubs/grounds (none of which are as unique as Elmwood Park) to look at their practice facilities. I am totally convinced after visiting other cricket grounds in Christchurch (refer Appendix 2) that the Community Board should not approve the OBCCC Option 6 proposal.

Alternative Proposal

Without wanting to criticise any of the parties involved, the consultation process (post the Community Board meeting of 12 August 2019) has, to a large extent, been about the OBCCC presenting positional variations of the same nets configuration proposal. There has been little opportunity to consider alternatives. There is an alternative however which is documented below that will substantially reduce the impact of the club proposals on Elmwood Parks Eastern boundary and which caters for the OBCCC needs. I firmly believe this is a very fair compromise.

The 'alternative proposal' is explained in the attached drawing (**Appendix 1**) complete with measurements. Although self-explanatory, the main points of the 'alternative proposal' are:

- 1) There would be two 37m x 3.5m 'closed in nets' on Astroturf situated in the North East corner. Note that this area is already taken up by club buildings.
- 2) The proposal involves the new/proposed pavilion being moved approximately 6m further south.
- 3) Two 12m x 3.3m mobile nets on Astroturf south of the pavilion. These nets would be used in situ or moved on to the main cricket wicket for practice as and when required. These nets would be netted on top. At 3.3m wide these nets are designed to fit inside the closed nets during the winter months. Note that the mobile nets are aligned parallel to the south end of the new pavilion so the open end of nets face away from the pavilion as well as the Eastern pathway.
- 4) Neither the fixed nor the mobile nets positioning will impede the view of the main cricket ground from the new pavilion.
- 5) This alternative proposal has less impact on the main ground boundaries than the club proposal.
- 6) Currently the old club rooms and existing nets configuration extends 45 metres south from the north fence boundary and impact only **24**% of the total length of the East boundary.

The OBCCC new pavilion/new nets proposal will extend 93 metres south from the north fence boundary and impact **50%** of the total length of the East boundary.


The 'Alternative" new pavilion/new nets proposal will extend 66 metres south from the north fence boundary and impact **35%** of the total length of the East boundary.

Given this alternative proposal I do not buy into the argument that safety at Elmwood Park during the cricket season or at other times of the year is dependent on the club having a 4 x 37m x 3.5m lane 'closed in nets' configuration spread over 518m². I would further argue given basic common sense and taking into account practice net facilities at other Christchurch clubs (refer Appendix 2), that if the club cannot adequately manage safety associated with two mobile nets (each of which is 12m long and netted top, sides and batting end), it raises the question of safety with respect to there being three separate cricket grounds with overlapping boundaries and pedestrian pathways that are well within striking distance of a good shot from any of the three pitches.

I am available to discuss my ideas with Council staff, OBCCC representatives or any Community Board member should they seek further clarification on my submission.

Finally, I would like to speak at the next Fendalton-Waimairi-Hareward Community Board meeting where the Elmwood Park lease is on the agenda.

I am writing to explain my opposition to the proposal from the cricket club on the following grounds:

- 1. This proposal involves at its heart a take-over of Elmwood Park by what is at the end of the day a minority group. Call it public interest (local community) versus private interest (cricket club) if you like. Whether the club has 600 members or whatever it is still a private group impacting on a public space. With respect I do wonder if the Council has lost sight of this fact. If granted this proposal will without doubt turn this lovely park into a cricket ground.
- 2. Mr Wakefield representing the cricket club says we do not recognise the hundreds of families who collectively use the park. We are the hundreds of families who collectively use the park as our local amenity. We don't drive here to use it as most cricket club members do. By the enlarged size of the proposed pavilion, the position of the building encroaching far more into the green central space that is in essence the heart of Elmwood Park, and the sheer size and position of the nets, the park is in essence tipped too much in favour of the club's interests and local families of whom there are hundreds have their interests placed firmly second.

My strong objection is to the sheer size and footprint of their project on the green space which is the park's identity and its reason for being as a suburban park first and foremost, not the project itself.

3. The information put in the public domain by both the Council and cricket club has been misleading and incomplete. The whole process has been difficult for people like me to even get an accurate idea of what the finished sports complex would look like in the flesh. The material on the Council's website is not very clear and gives a misleading idea of the impact of the sports complex in total. I have included visuals I got done to illustrate this fact and you will see what I mean. The current cricket club is shown on the basis of what was consented by Council in the past.

The signs erected at the entrances to the park are similarly misleading and if I didn't know better looking at them I would think the impact of the complex wasn't that great. I have spoken to a number of local residents who formed that view and have not bothered to object. But in reality it is a much bigger footprint on the central green space than what is currently there now. Also the article in The Press of April 14 which I also include yet again misleads the public as to the impact of this proposed complex, in part due to the angle of the shots and the lack of an accurate portrayal of the 3 D proportions of the pavilion and nets as a whole particularly as compared to the present set-up. The whole thing looks slightly ghosty and transparent!



As a neighbour of the park it has been really hard during the Covid crisis to talk effectively with other people in the park's vicinity. Calling a meeting or doing a letter drop etc was not permitted. This has also put us at a disadvantage.

- 4. I am left with many unanswered questions both about the physical side of the proposal and also what I have heard the Council term the 'functionality' of the cricket club's sports complex.
- Will the park be more of a cricket academy for the city as a whole and expand even further from its present club base? If not why the need for 4 huge nets?
- What about mobile nets? How many will be placed at the park and where?
- What is proposed for the land behind the pavilion? I gather the path is proposed to go there again reinforcing the dominance of the cricket ground look and feel over the park.

- Where will the club and others store excess gear? Will an extra storage facility like a container be brought in and put somewhere for this?
- What's the back of the pavilion which will be highly visible going to look like exactly?
- How exactly will the club block off access by the public to the large space between the end of the pavilion building and the start of the proposed nets? This will effectively block off the lovely view of the treelines on the other side of the park and prevent access to the public along half that main pathway between St Andrew's Square and Heaton Street.

At no point has the club shown a real willingness to engage with the community on all this, quite the opposite in fact. When Mr Wakefield states in The Press article April 14 that he spoke face to face to 'community members' about his retractable netting proposal and nearly all agreed with it, he needs to appreciate that they are the Council, not the community, which he has not approached at all.

5. We need to look after this treasure and respect its history. This park is for the surrounding community first and foremost as are all suburban parks. The community loves and values it greatly as is apparent by the number of locals using it at any time of the day. It is one of Christchurch's treasures. Does the Council agree with that statement? If it does, please do not allow the club to take over the park with a sporting complex of this size. Again I reiterate it is the sheer size of this sports complex that absolutely steps over the mark.

If the Club wants and needs this sort of complex then Elmwood is not the appropriate park for them size-wise, despite its appeal for other aesthetic reasons. The combining of clubs was their decision to make but having made it, the consequence is they are now too big for this park if this is what they need to operate.

If they absolutely need 4 huge permanent nets with artificial turf then their needs would override too greatly the needs and wants of the community for whom the area was originally formed.

6. I do question why the net area needs to be so vast. That the nets extend about half way down the main entrance pathway between the fence along the back neighbours and Heaton Street entrance and necessitate such a large expanse of astro turf makes this proposal an unreasonable increase on the present net size and that impact is of course exacerbated by the pavilion being pulled out so far from the corner where it is at the moment.

Decrease this impact by less net area, not by nets that will be there for well over half the year in the warmer months and show a real willingness to compromise and decrease the net area all year round permanently.

The temporary net suggestion is simply not workable the way it's proposed. If the temporary net area were to be taken down from April 1 each year how safe will it be for people using the adjacent pathway when balls can easily be hit out onto the path of such users? If the club is concerned about safety what's their view on this? I personally am yet to be convinced the nets will be altered as suggested anyway given how the club has totally ignored any requests over the years to clean up the eyesore behind the present pavilion building.

I would also like to see a change in the proposed colour of a smaller net area to grey not black so they blend in a bit better with the environment.

Just offering to have ugly removable nets that are there 7 or 8 months of the year leaving possibly large poles, concrete and astro turf is not meeting the community half-way it seems to me.

Finally I would like to thank you most sincerely for your care and attention in reading my submission and especially perusing the photos etc I have attached which reinforce my main argument of this proposal being just too big for this local park.

I would also like to record my wish to speak at any further Council meeting on this issue.

Re: Elmwood Park

- Old Collegians Cricket Club
- New lease/licence for new pavilion and practice nets.

My name is **Frank Pipe** and I raise the following questions and points of concern as owner of and a user of Elmwood Park for over 30 years. My family and I have belonged to the Elmwood Tennis club and have played sport, walked our dogs and run at this park almost daily. We meet other residents and community members doing the same and have always found it a great social environment.

I note that the Christchurch City Council hold Elmwood Park as a place of <u>historical and social</u> significance.

" ASSESSMENT STATEMENT

Elmwood Park is of overall significance to Christchurch, including Banks Peninsula. The park has historical and social significance due to its association with the **Rhodes family**, its acquisition by the city for use as a suburban park, and its development from a private estate to a public park by James Young, Curator of the Christchurch Botanic Gardens and Superintendent of Reserves.

Elmwood Park has cultural significance as it reflects the importance of open public spaces to the people of Christchurch and the growing recognition of the need for children's suburban playgrounds. The park also has cultural significance as a site of commemoration.

Elmwood Park has aesthetic significance for its balance of open greenspace and large mature trees. The park has technological and craftsmanship significance for its ornamental landscape fabric (surviving posts from Victoria Square, the Halswell stone fence and iron gates) which predates the parks development. It also has technological value for the evidence it may contain relating to its arboriculture record. Elmwood Park is of contextual significance as a local landmark on a busy Christchurch residential street, and of archaeological significance because it has the potential to provide archaeological evidence relating to human activity, including that which pre dates-1900.

CCC Heritage File, Elmwood Park "

Question - Have the Heritage team provided a review of the suggested pavilion and nets, with particular reference t the impact on the "importance of open public spaces to people of Christchurch and the growing recognition of the need for childrens suburban playgrounds."?

Question - Is the pavilion owned and funded by the CHCH council and leased to the cricket Club?

Question - Who is responsible for the facility as the current facilities are often an eyesore and unkempt?

It is accepted that a new pavilion would improve the current situation for the cricket club but this should be balanced with the fact that cricket is a summer sport and the park is for the whole community, not just sports people. It should be an environment that continues to provide the open greenspace and relaxed treed landscape, unencumbered or dominated by buildings and structures.

- A complete building the pavilion should be able to house all the equipment associated with any sports and additional items used ie wicket covers, rollers, waste bins, screens. (No additional Containers parked up alongside.)
- <u>Provide a water</u> fountain for players, park users and dog walkers (as per other parks within ChCh)
- Additional <u>rubbish bins</u> adjacent to the decking / seating area.
- <u>Toilets</u> which are maintained and open daily to users of the park. (the toilets currently provided by the council are outdated and of average quality)
- <u>Detailed floorplan.</u> No detail layout of the pavilion was presented so it is hard to
 gauge the room sizes. It is stated that the pavilion is not to provide a large space
 for social functions but is to meet the requirements for senior cricket
 competition. This is all too ambiguous and a detailed floor layout should be
 provided so the community and affected parties can be clear as to proportions and
 then comment objectively.
- The main hall /room of the current Club rooms is used as a gym which begs the question "why are they after a large room when they never use their existing one".
- And will the gym cease to operate out of the pavilion. I find it hard to believe that commercial operations are allowed to run in the park. Clarity on this would be appreciated.
- The council have advise that "The commercial gym is currently operating from the remaining section of the Club's former pavilion building under a temporary approval under the Canterbury Earthquake (Resource Management Act Permitted Activities) Order 2011 for which there is a final expiry date. " could you please advise us what that expiry date is?
- <u>Parking</u> as parking is already an issue on Heaton Street and in the surrounding streets, especially St Andrews square. What traffic assessments have been completed on this new facility?
- Noise- What assessments have been done?
- Practice Nets

I regard the placement of these to be both selfish and atheistically out of place within the greenspace that is Elmwood Park. The net location takes up <u>more space than the pavilion</u>, yet is used for such a limited time.

- Has there been investigation into seasonal / removable options?
- Could not two nets be incorporated at the same side as the pavilion . On the fence / north side of the new pavilion.
- In summer very rarely do you see more than two nets used and in winter are rarely used at all.
- My research found only four other clubs have permanent nets- all have large sports grounds as opposed to a park.

Moveable Cricket Nets

I have attached a very positive alternative for the proposed fixed cricket nets at Elmwood Park. This option took me less than a day to obtain from a local supplier/manufacturer. (NB - I have no connection with this supplier)

Please review the visuals attached, the pricing and dimensions

This option is;-

- · Very cost effect
- · Alleviates the need for a permanent structure and concrete base.
- · Allows for the nets to be stacked inside each other when not used.
- · The nets can easily be deconstructed and stored over the off session (leaving a net out for those who train over winter months)

I would request that there be full disclosure as to reasons why moveable nets are not a suitable solution.

• Health and Safety issue. I have reported to the council that one of their staff have given gate key access to members of the Elmwood Croquet Club. They leave these gates open and cars are driven and parked on the grass opposite the Croquet Club. More than once I have had to stop vehicles speeding here when dogs and children are running and playing between the park and children's playground. One time in particular it was inches between a toddler's safety and a terrible accident by an elderly driver. I feel a large structure in that area would further distract and confuse people.

Elmwood Park - the bigger picture - Full Disclosure required

There have been some discussions around a newly formed group called **The Elmwood Club**. The name appeared on the park hoardings around 2015 and we were told by the council that it represented a number of clubs that had lost their facilities due to the earthquake. One could then rightly assume that once life in Christchurch returns to some form of normality that they too would return to their former communities. But this now does not seem to be their intention at all. It would appear that they wish now to take over our community park and erect a mini Cowles stadium.

In April 2015, the board offered full disclosure of the Elmwood Club and its plans. The Old Collegians discussion should not be done in isolation as it is the collective changes that will scare our park if not done correctly.

What is the link to this current application?

OBC state on their website that they are proud members of The Elmwood Club. And on further investigation you would find that 4 of the 6 Elmwood club board members have been prominent members of the OBC - past president and board members.

Why are the public not being told the true picture, full disclosure is what I am expecting from the Council. Gather all the facts and advise those who elected you.

With all the cards on the table the local community, who are the people directly affected can make fact based decisions .

The Vision – as stated by The Elmwood Club (TEC) is to build a facility on Christchurch City Council leased land and Ministry of Education Land. A partnership between school and community.

Problem

- There is no parking, Traffic in Heaton Street and surrounding streets are to capacity already
- Who would fund such a project? The Council or the groups themselves? Talk is around \$6M.
- Why is the club trying to draw residents from all over Christchurch to an already over used park with no excess space. If they are truly passionate sports people then great go ahead and talk to the council about all the spare land around Dallington, QEII, or Kerrs Reach, Avonside.
- Members of the Elmwood Club come on !!! Affiliated groups out of zone and nothing to do with our community.
 - Lincoln University Sport and Shirley Volleyball, St Nicholas Netball as a member of our local community is a long bow to draw. I am sure that many groups across Christchurch have residents living in Merivale - that doesn't give them a right to include for instance surf clubs, equestrian groups etc to align themselves to an Elmwood Club.
 - We have NO Netball Courts or hockey fields.

In summary

I feel that the proposal was lacking background, context and detail. I have tried to provide this with the above summation but must insist that the community board (especially the new board members) are given all the facts before they make a decision that will change the face of this piece of Christchurch culture and history.

The timing of the submission around the school holidays was always a problem. Which combined with the Covid-19 Level 4 and 3 restrictions has made it impossible for the community to fairly assess and communicate on this matter. We are not able to gather and discuss the options as a community nor are we able to distribute leaflets around the area.

There are too many unanswered questions and a need for;

- A complete traffic and parking assessment given the amalgamation of the two clubs and their boasts as the largest Cricket Club in the South Island.
- A noise assessment and plan to give surety to local residents that the Club will not turn into a function centre.
- Full disclosure of the plans for The Elmwood Club. What is the need for this when the Cricket and croquet already have club rooms.

If you are able to provide some answers to these points I would be most grateful. These are decisions that affect not only the community now, but generations to come.
