On the occasion of the opening of the Yaldhurst Memorial Hall*

1. The devastating Christchurch earthquakes compromised the structural integrity of the Yaldhurst War Memorial Hall and brought an end to nearly 60 years of community use and enjoyment of the facility. For the last 13 years the Yaldhurst Rural Residents Association has demonstrated an unwavering commitment to save the hall and restore it for the benefit of generations to come.
2. We are delighted to support the recommendation to vest ownership of the hall to our organisation and to be given the opportunity, and mandate, to start the process of restoring it as a treasured community facility. This opportunity is empowering for our community. It brings together the knowledge, enthusiasm, and expertise of our local residents. We confirm our determination to deliver a facility that honours the past and provides our community with a sense of belonging and a place for recreation and reflection.
3. Our organisation has already obtained pledges of time and resources from local businesses and residents to get the restoration project underway. Granting ownership will give us proper legal standing to apply for funding from charitable trusts. We also hope to be eligible to apply for financial support from council funds.
4. Since the last Council meeting, we were granted access to the hall to inspect its condition – and we can report that the hall remains in surprisingly good condition. Both our Quantity Surveyor and Engineer are very comfortable with its state. The hall was very dry and did not smell despite it being locked and boarded up for so long.

5. We are inspired by those who established the hall back in 1946. A small parcel of land was gifted by the Kyle Family for the purpose of establishing the memorial hall. The committee set up to build it fundraised 600 pounds – and acquired a pound-for-pound subsidy for the grant to build the hall. We remember that the hall itself the memorial, not just the plaques inside. We remain conscious of the guidelines issued to local authorities at the time – to create:

*...something vitally living, something from the very nature of its use and enjoyment will ever keep before us and the generations that follow us that freedom of life and personal expression for which our men and women fought and fell..... the type of memorial which best embodies this ideal is the community centre where the people can gather for social, educational, cultural and recreational purposes...*

6. We are committed to celebrating the heritage features of the building and will be adopting more of a conservation approach. We have no intention of transforming the hall into something flash and modern. Our sustainable focus on repair and replacement is not only the environmentally responsible thing to do – it is also financially and socially responsible.
7. Our vision is for the hall to address four key areas of wellbeing:
  - a. *Reflection* – to deliver on the original intent of the hall as a memorial for those who have gone before.
  - b. *Connection* – the hall will be a place for people to come together for different reasons; for support groups, performances, meetings, and be available for family events.
  - c. *Activity* – to provide a convenient location to promote physical health; indoor sports, yoga, fitness classes, martial arts, dancing.
  - d. *Learning* – a large space for local schools and preschools to access, and for community members to engage in classes.
8. Our aim is for the hall to be restored and lifted to a standard so that it is safe and functional and to do this at an achievable and reasonable cost.

9. As we raised at the council forum in January, we believe there are finer details that still need to be worked though on the arrangements between our organisation and the Council, namely:
- a. Ongoing lease arrangements, rights of renewal and extensions of timeframes if required;
  - b. Independence of decision making from the council and the ability to implement our own repair strategy and not be expected to meet the scope of works previously proposed by council
  - c. To have equal opportunity with other community groups to apply for grants from council funds;
  - d. Consideration given to waiving the fees associated with obtaining consents.
10. These issues are not insurmountable and our impression was that counsellors agreed at the meeting earlier this year. We are happy to speak to this submission in greater detail, however we are confident that that level of community support and our rationale, motivation and capability to deliver on this project have been ventilated and are now well understood.
11. We would like to take this opportunity to thank the council for their consideration and for trusting us with the responsibility of this project.



### **Long-term Plan Submission 2024-2034 for Christchurch City Council: New Zealand Events Association**

New Zealand Events Association (NZEA) welcomes the opportunity to outline the significance and requirement of continued Council investment into events-related functions carried out by Christchurch City Council.

#### **Key feedback**

The events industry is integral to our national identity; when it flourishes, so does New Zealand. It brings economic diversity, resilience, generates jobs, and fosters regional prosperity while showcasing our cultural richness and providing memorable experiences, promoting pride and social connectivity both locally and globally.

Across New Zealand, local government faces significant challenges. NZEA recognises this pressure and the challenging decisions Councils must make. Nonetheless, we assert that funding for core events activities by Councils is an investment in the economic health, wellbeing and future prosperity for the city of Christchurch, an investment that will yield a healthy return on investment for your residents and visitors.

It is great to read in your Long-Term Plan that events contribute to Christchurch being a vibrant city where people want to live, play and visit. And the desire to make Christchurch a creative, cultural and events powerhouse.

Drawing from international evidence, we argue that Council expenditure in these events functions should be regarded as an investment, not a mere cost. This expenditure will yield dividends in the form of increased economic activity, enhanced Council revenues, more and better jobs, and increased vibrancy across the region. During this period of economic uncertainty and challenges, nurturing vibrant events activity is a logical and sensible step for Councils to take, not only for the sake of tourism but also for the wellbeing and satisfaction of local residents. Beyond the immediate economic benefits, fostering a lively events scene also contributes to making a place desirable to live in. Communities thrive when there are vibrant cultural and recreational opportunities, making the region not just a destination for visitors but also a fulfilling home for its residents.

#### **The events industry**

Events encompass a broad spectrum of activities that attract participants and audiences, contributing to the vibrancy and cultural richness of a region.

Events spend is an investment in the wellbeing of Christchurch. Council spending on events activities such as event promotion and venue support is widely recognised as an investment rather than a mere cost.

As an investment, resources allocated to these areas generate returns that surpass the initial cost. This is why countries and cities worldwide invest in events functions. Generally, for every dollar invested in the local events economy, there is a direct return for the funding party, such as the local government entity, with even greater benefits for businesses and individuals within the local economy. This rationale for events investment is globally accepted.

In cases where such funding has been withdrawn, the outcome is typically a noticeable decline in events activity, followed by a gradual period of recovery after reinstating the funding. Evidence suggests that when events-related investment is reduced, visitor spending decreases immediately and continues to decline. Fortunately, such funding reductions are rare, indicating the recognised and valued boost generated from this type of investment.

Events play a crucial role in stimulating demand from high-value visitors and addressing challenging issues such as seasonality or fluctuations in demand. This amplifies the benefits of investing in programs that attract events, particularly those that can provide a boost to fill otherwise quiet periods. By attracting events, regions can create a more balanced and predictable demand pattern, sustaining businesses and the jobs they create.

NZEA submits that, in alignment with the evidence detailed in this letter that Councils should support and enable events in Christchurch by ensuring adequate base funding for events functions, aiming to reap both the return on investment and the intangible place-making and community benefits that will result from this expenditure.

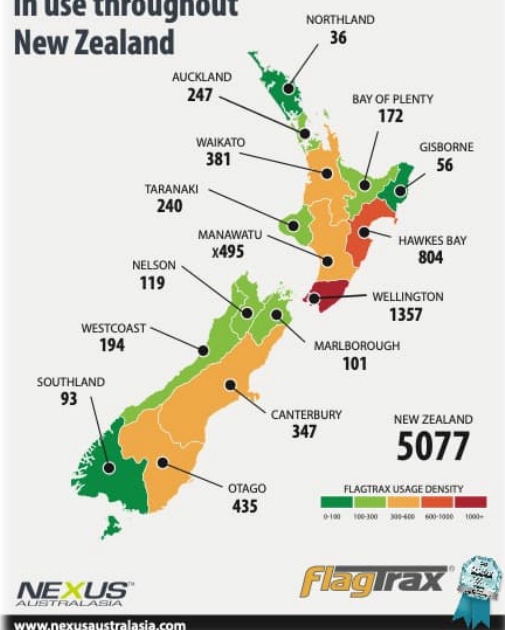

For years, we have collaborated with councils to enhance the festive atmosphere with street banners, also known as 'street flags', in towns and cities across New Zealand. These banners not only create a successful look but also facilitate event communications and can even generate revenue for councils.

The Christchurch City Council has approximately 400 brackets spread across the city and its suburbs for attaching street flags. These brackets are mounted at heights exceeding 6 meters on lampposts. However, the current brackets being used have several significant drawbacks:

- Work is conducted at a risky height.

- Damaged flags often remain in place due to high replacement costs, leading to a negative brand impact.

All these issues contribute to a substantial cost for you and your stakeholders, needlessly complicating what should be a straightforward process.

Our innovative product, FlagTrax, transforms the way street flags are changed, offering greater effectiveness at a fraction of the cost. FlagTrax was introduced in New Zealand in 2007, designed and tested by industry experts to suit the country's environmental conditions.

FlagTrax allows a single person to effortlessly raise and lower street flags from ground level in seconds, eliminating the traditional expenses associated with flag changes.
