A copy of this licence, together with signs showing the age restriction must be clearly displayed.  
Persons under the age of 18 years shall not be sold or served Alcohol, but may be supplied by their parent or guardian.
- (e) **Noise from the function shall be controlled so that unreasonable disturbance is not caused to neighbouring residents.**
- (f) The premises are to be vacated within 30 minutes of the time at which the premises are required to be closed for the sale of Alcohol.
- (g) This licence does not excuse the applicant from obtaining where necessary a Building Consent in respect of tents or marquees.

The licence will issue pursuant to Section 22 Sale and Supply of Act 2012 forthwith.
